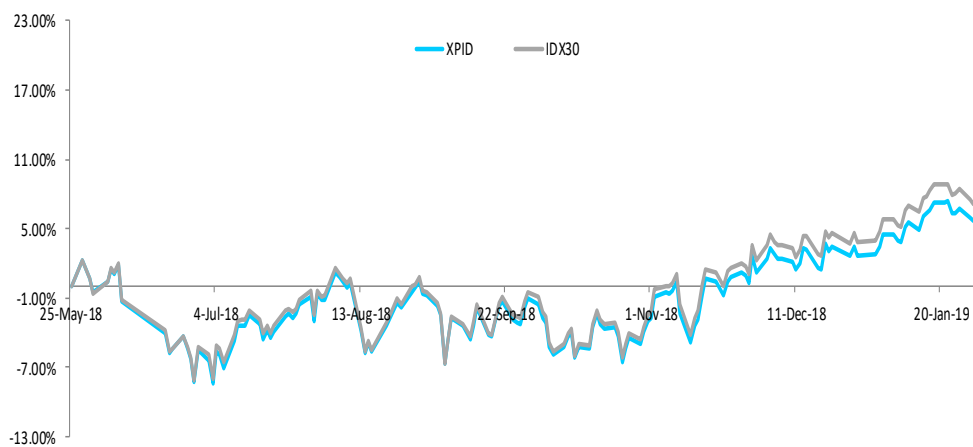
ABOUT PINNACLE
