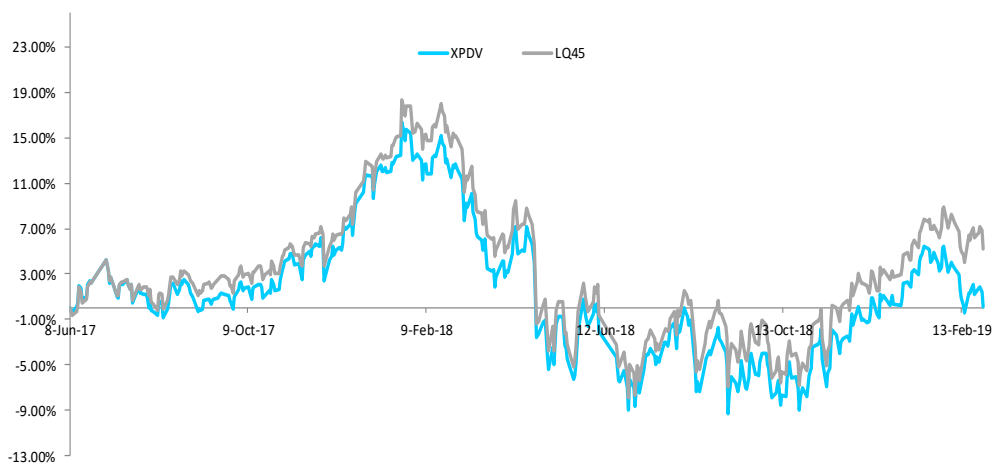
ABOUT PINNACLE
