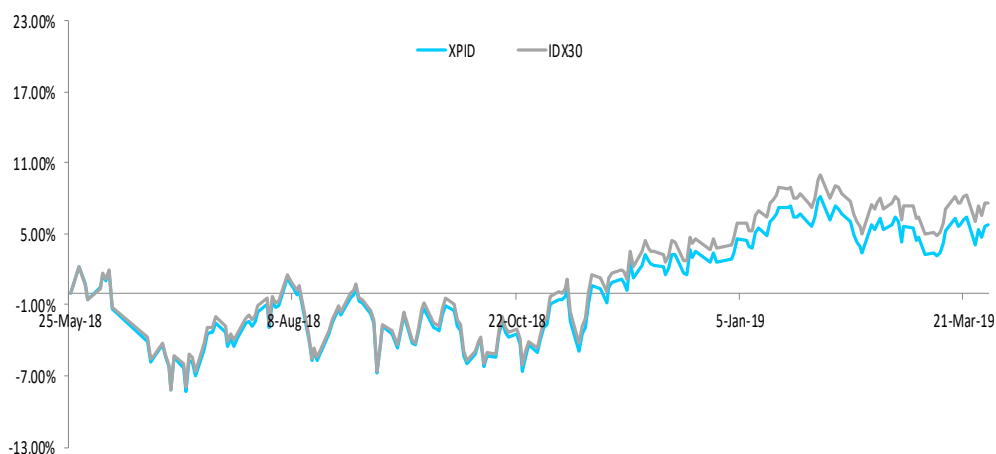
## ABOUT PINNACLE
