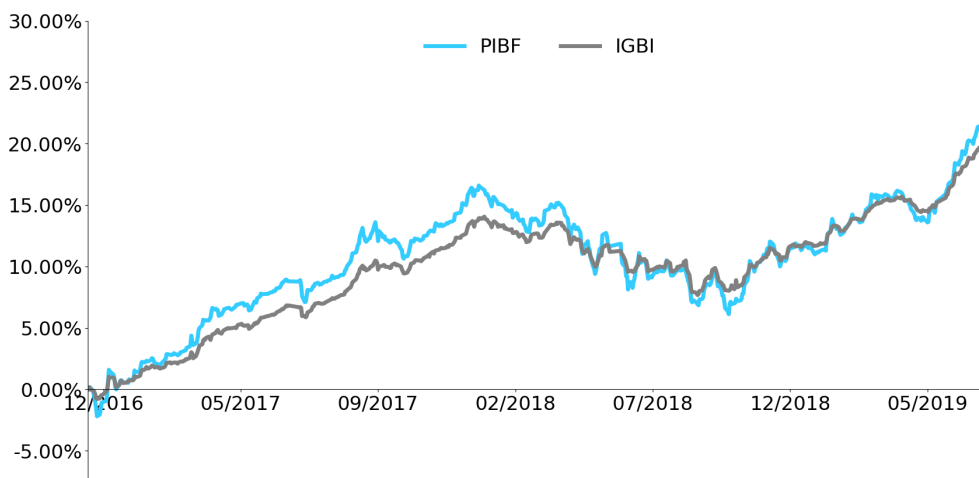
ABOUT PINNACLE
