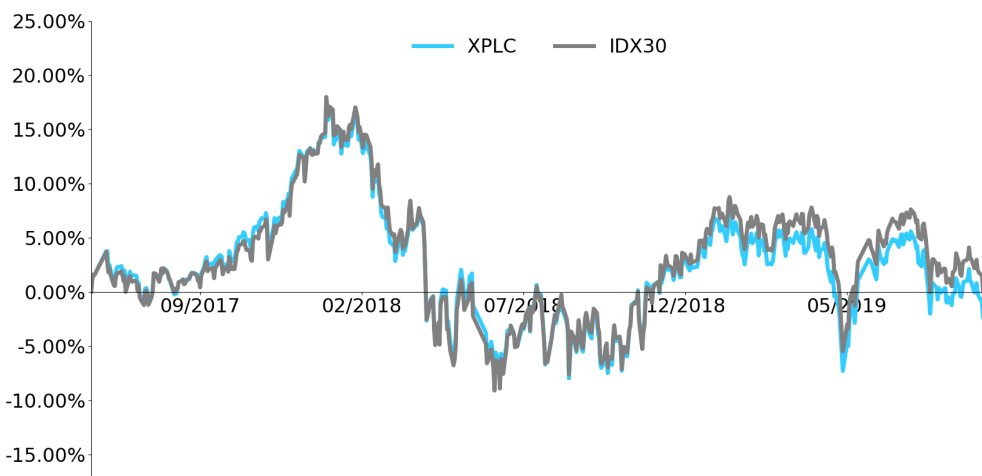
ABOUT PINNACLE

INVESTMENT OBJECTIVE

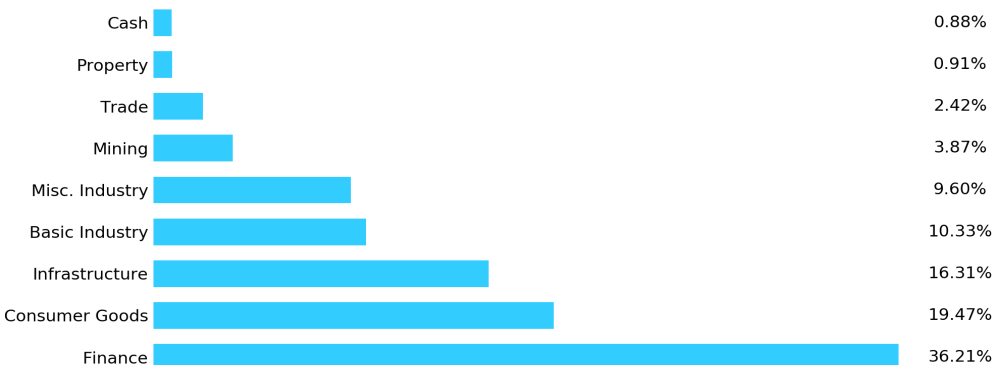
