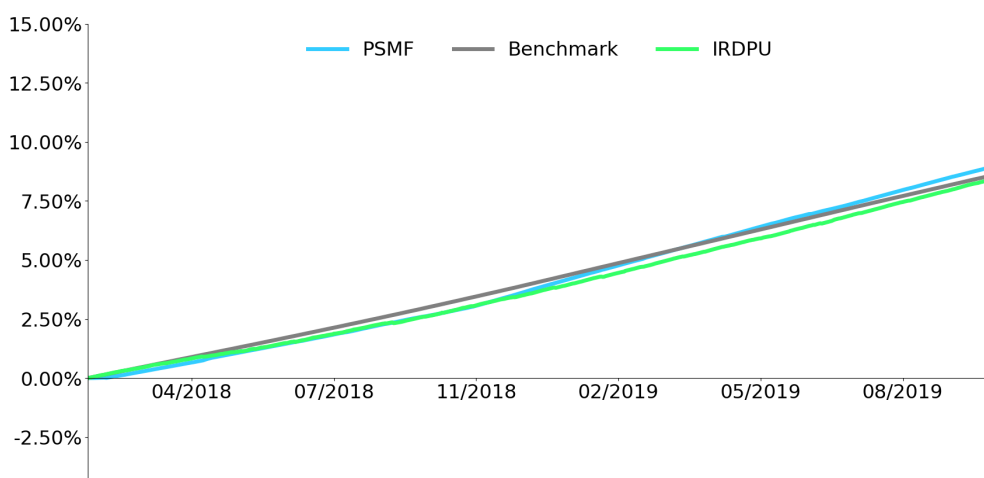
ABOUT PINNACLE
