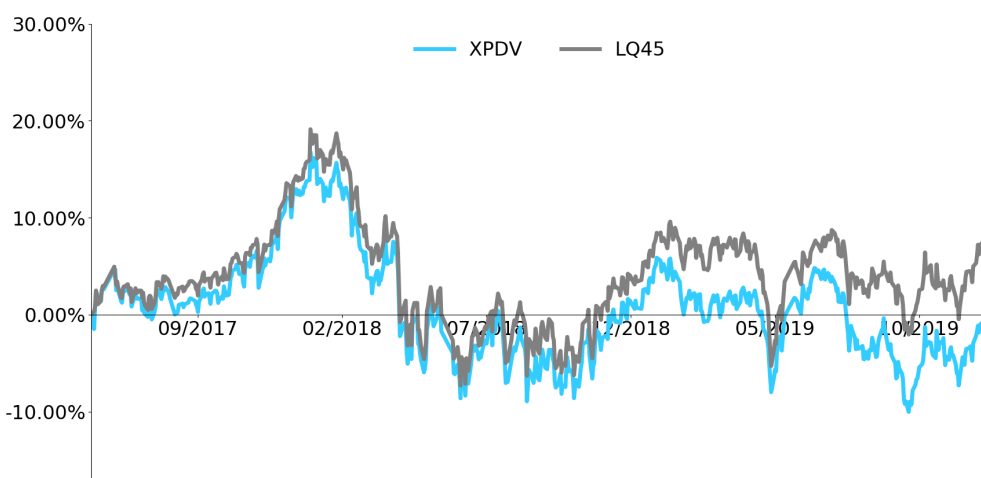
ABOUT PINNACLE
