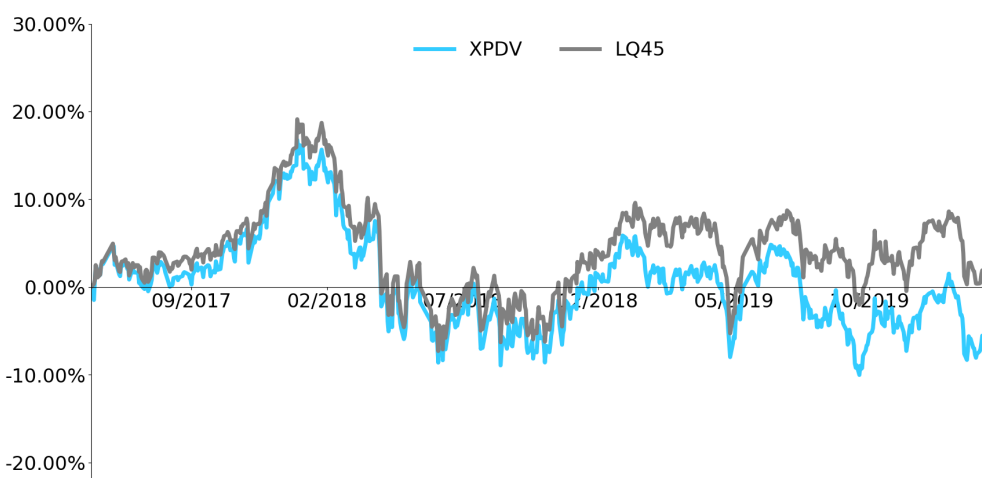
## ABOUT PINNACLE

## INVESTMENT OBJECTIVE

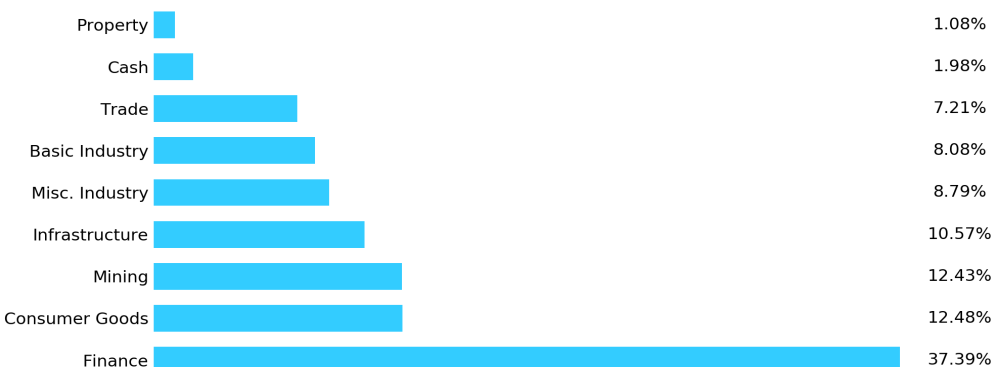
