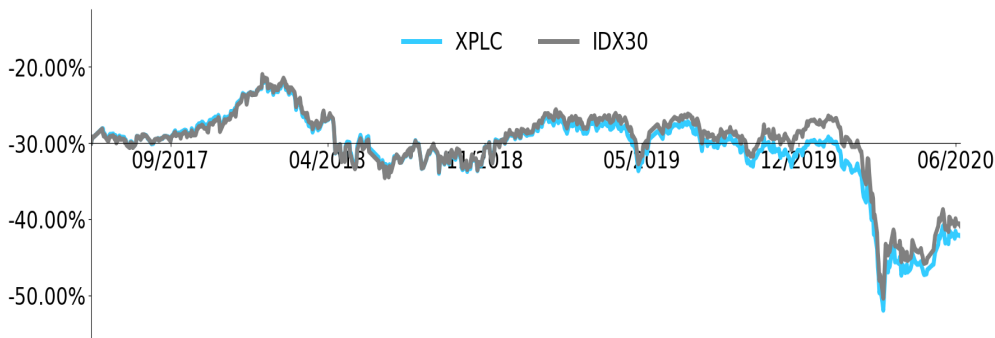
## ABOUT PINNACLE

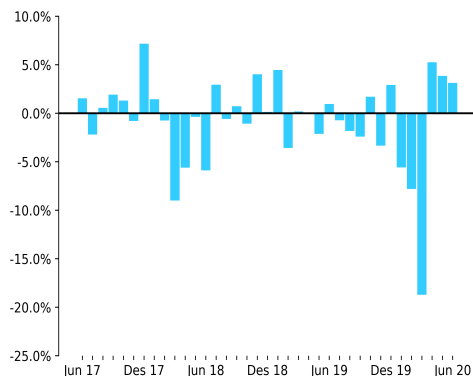
## INVESTMENT OBJECTIVE

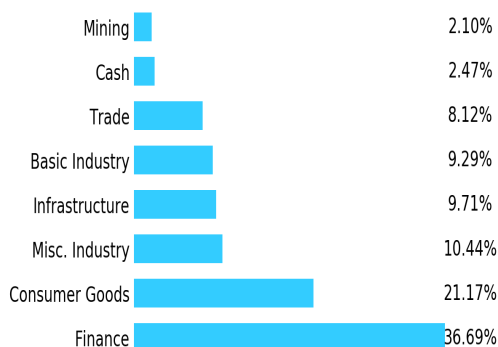
## FUND PERFORMANCE (%)

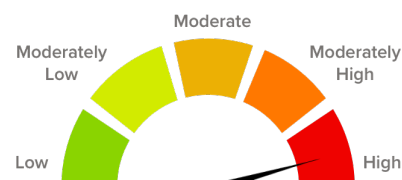
