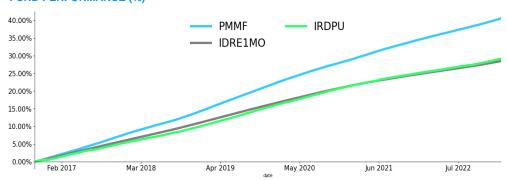

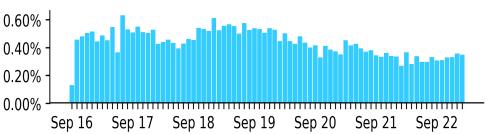
INVESTMENT OBJECTIVE
