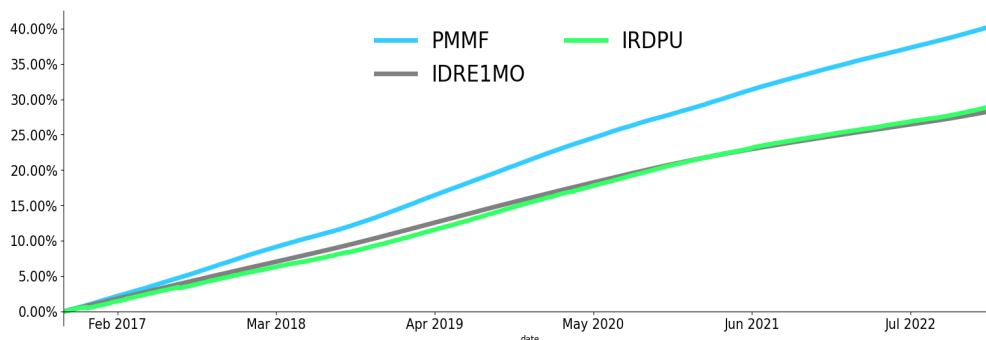
ABOUT PINNACLE

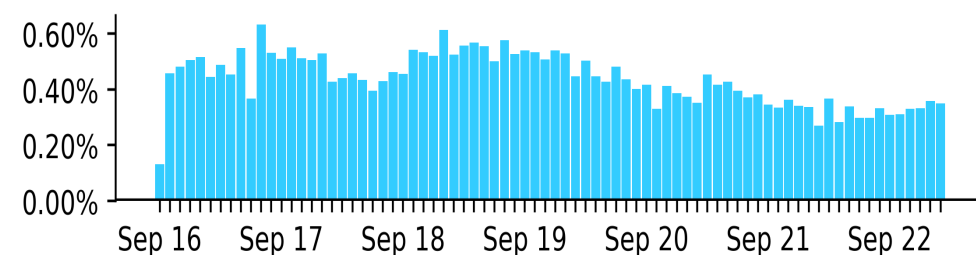
INVESTMENT OBJECTIVE

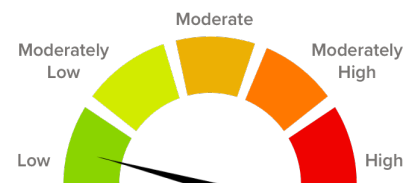
