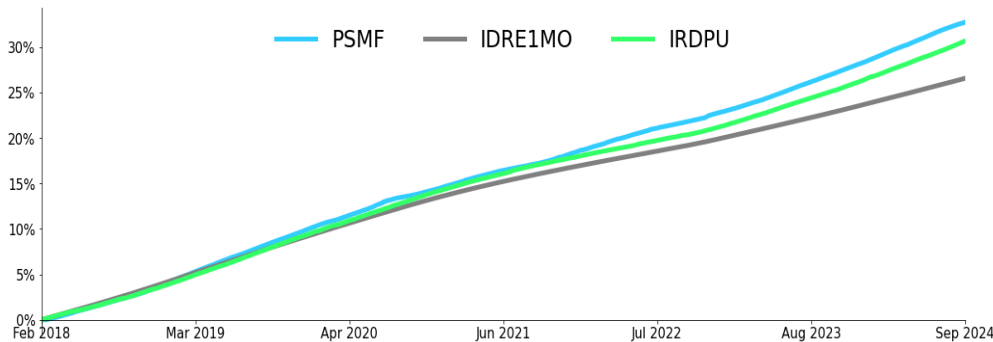
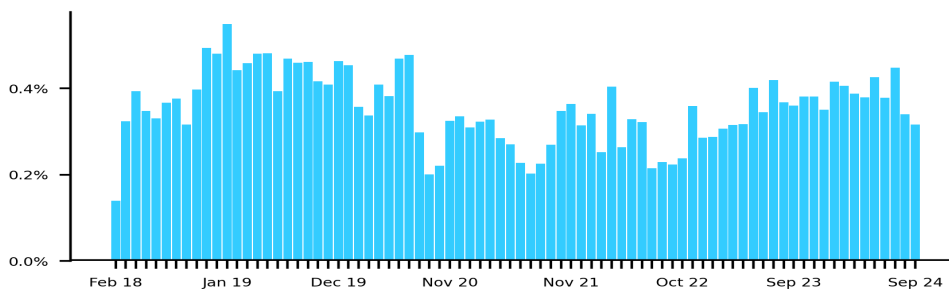


**ABOUT PINNACLE**

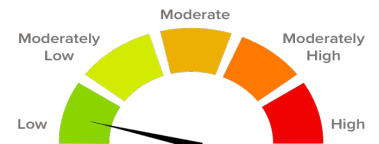
