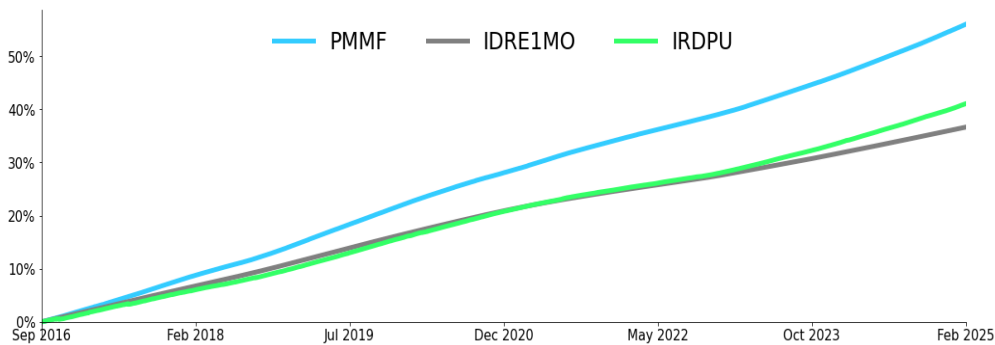
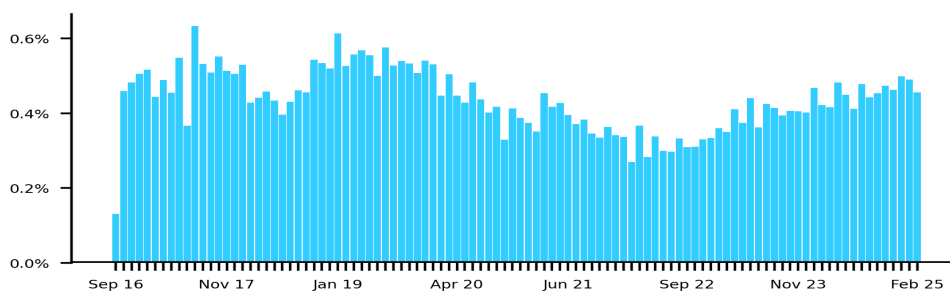


ABOUT PINNACLE
