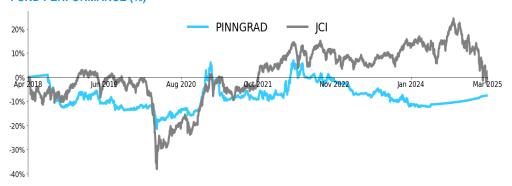

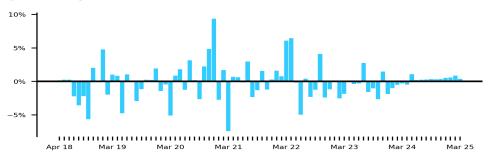
INVESTMENT OBJECTIVE
