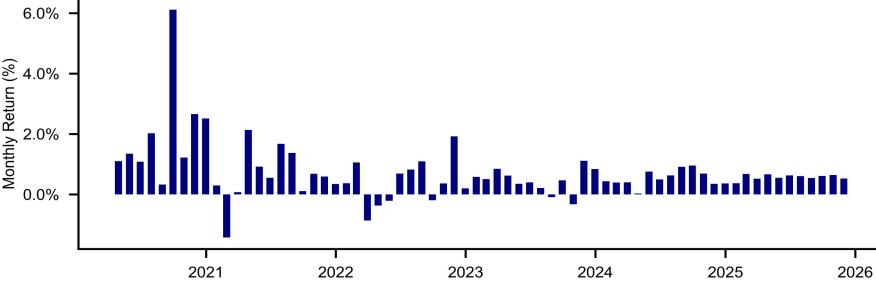
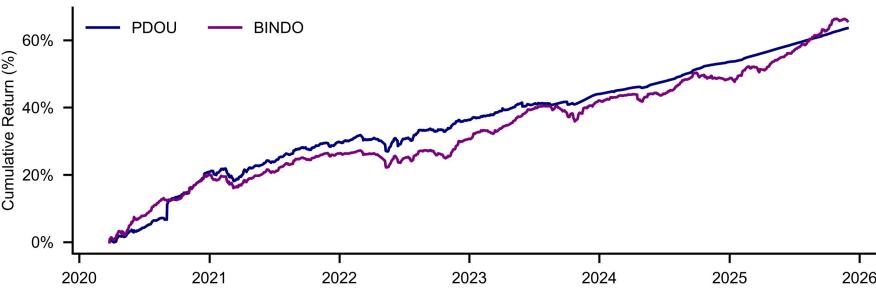
## About Pinnacle
